

FCNC Nomination Committee Report

May 27, 2020

The committee met early 2020 with previous member Geraldine Brannon hosting and starting our meeting. Our first order of business was to elect a chairperson. I was elected and Brenda agreed to fill in for me during absences.

Second order of business - After review and discussion of FCNC committees and positions, we believe the following committees all have proper representation for 2020 - Christian Education, Evangelism, Literature, Missions, Program, and Trustees of Real Estate.

We request the name of MaKayla Matthews for the Christian Education Committee approved at FCNC Mid Year Meeting.

On the Finance Committee, we believe the committee has enough members to complete meetings and work. Chairperson Jimmy Spaulding confirmed that with current work assignment and committee members, this committee could accomplish their work.

We were asked to find seven members for the Trustees of Trust Funds committee. We were provided suggested names from members of the AOC, and we contacted these, considered and asked others that qualified, and submit this list for consideration and approval for the committee.

In general, I would like to request committee make up in FCNC be reviewed and evaluated. There have been lots of changes since the committee structure, member count, etc. were established, and I believe it needs revision. It appears we are following some NCYM ideas and structure, and in my opinion, not adjusting to our current situation. The FCNC membership currently looks like this; Contentnea at 4.3%, Southern at 45.4%, Western at 23.3%, and Yadkin Valley at 27%. The following thoughts and questions cross my mind. How many members does each committee need to accomplish the objectives? I think it is less than 8 members for each

committee. If we can get this number "adjusted", it helps us find people to serve, and rotate, without being overwhelmed with commitments. Maybe FCNC wants to decide that each Quarter's Nominating Committee finds people from their own quarter to fill the positions, and there is no need for FCNC Nominating Committee, freeing up even more people to serve. Either way, it seems the days of getting two committee members from each quarter have passed, at least for now. We should consider revising committee member counts to the minimum needed to conduct business and make decisions, and the makeup of the committee from the Quarters probably should more closely match the quarter membership as a whole. For example, maybe each committee would have 2 from Southern Quarter, and one each from the other Quarters, making the member count a total of five. I am sure this idea is not new, but I believe it needs renewed consideration and changes in order to do the work of the Nominating Committee, whether that is at the FCNC level, or at the Quarter level.
